Director’s Note

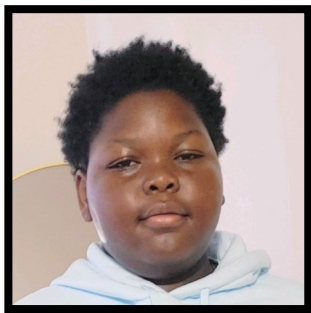
To our incredible youth,

PLOT SUMMARY

The prosecution, representing religious tradition and skepticism, presents witnesses from history and modern science who deny Jesus' divine identity.

The defense, representing the followers and eyewitnesses of Jesus, passionately argues for the truth of the Gospel using compelling testimonies and scriptural insight.

As the courtroom proceedings unfold, a humorous jury selection, dramatic witness testimonies, and soulful musical interludes from "Ambassadors For Christ" invite the audience into a decision of their own—What's your verdict about Jesus?
